Hi Monica,

I called to make sure you received the ORR request from Garland Favorito with Voter GA but Cassie said that you were in a meeting. I want to make sure that you have received it, so I am forwarding it to you from my copy. I am forwarding it to the email address you used to respond to my emails in the past.

I am also adding these links to O.C.G.A 50-18-71 and O.C.G.A. 50-18-72. According to Georgia state law, this records request for copies of the original ballots, in other words, the paper ballots printed after a vote is cast, but prior to being fed into the scanner is not exempt, and must be fulfilled, according to the ORR laws.

Dear Director Franklin,

I am following up on an Open Records Request I submitted on the night of May 24th for a copy of the ballots from the 2022 Republican primary. We can accept a lower resolution than previously stated provided that the copies are made independently of the Dominion voting system equipment and software. The ballots we request are non-exempt records subject to disclosure within 3 days under ORR law. O.C.G.A. 50-18-71. We are not requesting ballot images since we have already found Fulton. Co. 2020 election ballots were electronically altered prior to the certification. Therefore, the Dominion ballot images are not trustworthy. The timing is urgent since we need to obtain the copy before the ballots are transmitted to the Clerk of the Court and sealed after certification. If you have any questions about our request please call.
